Outcome of the Board Meeting

1. Sixty Fourth Annual General Meeting

The Sixty Fourth Annual General Meeting ("AGM") of the Members of the Company will be held on **Thursday**, **30th September 2021** at **4.00 p.m** through Video Conferencing ("VC") / Other Audio Visual Means ("OAVM").

2. Fixation of Record Date
